## **RULES & REGULATIONS**

- 1. The Organizational election for the following posts of executive body of OGPTA shall be conducted as per the schedule mentioned in the notice.
  - President 1 no.
  - Vice President 1 no. ii.
  - General Secretary 1 no. iii.
  - Joint Secretary 1 no. iv.
  - Treasurer 1 no ٧.
  - Zonal Secretary 4 nos. vi.
  - Office Secretary 1 no vii.
  - Executive Body Member 5 nos viii.
- 2. The term of the executive body for which the election is being held is 2 years.
- 3. Eligibility for contesting the election is, the candidate as well as the two proposers should be genuine members of OGPTA & cleared all their dues up to 2018. This should be certified by the treasurer local unit / central unit in the nomination form.
- 4. All the details furnished on the nomination paper should be certified by the President or Secretary of the local unit / central unit on the nomination form.
- 5. Each nomination for election 2019 shall be filled in all respect, along with a deposit of Rs1000.00 for all posts to be paid either by net banking / DD in favour of Odisha Government Polytechnic teacher's association payable at Cuttack.

- 6. In case of withdrawal from contest, this amount shall be refunded and in case of rejection this amount shall be forfeited.
- 7. One member is eligible for filing nomination for one post only.
- 8. Contesting candidates can submit their nomination in person / by post / by email so as to reach the election officer within the stipulated time.

- All the communication pertaining to the conduct of OGPTA election 2019 from the election officer or contesting candidates must be circulated to all the members uniformly without any prejudice to the interest of any particular contesting candidate.
- The list of members eligible to vote shall be displayed at the venue of GB as well as in the website.
- 11. A member working in any of the offices / Institutions of a particular zone shall be eligible to contest for the post of zonal secretary of that particular zone only.
  - List of districts under zones :North Zone Mayurbhanj, Balasore, Keonjhar, Bhadrak, Dhenkanal, Anugul, Depgarh, South zone Malkangiri, Nawrangpur, Koraput, Kalahandi, Kandhamal, Rayagada, Gajapati, Ganjam, East zone Cuttack, Kendrapada, Jajpur, Jagatsinghpur, Nayagarh, Khurda, Puri, & West zone-Sundargarh, Jharsuguda, Sambalpur, Sonepur, Bargarh, Balangir, Nuapada, Boudh.
- 12. The decision of the Chief election officer shall be final in respect of any dispute / clarification pertaining to OGPTA election 2019. All arbitration shall take place at the office of the election officer only.
